

**TERMS AND CONDITIONS FOR
WESTFIELD'S "LITTLE BOOK OF BIG OFFERS" WOTIF HOLIDAY COMPETITION
2010**

1. Instructions on 'how to enter' and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

2. WHO CAN ENTER?

2.1. Entry is only open to Australian residents who hold a current passport.

2.2. Employees of the following (and their immediate family) are not eligible to enter: Westfield, retailers and tenants of participating Westfield shopping centres and the agencies associated with this promotion, plus employees of Wotif.com Pty Ltd.

3. HOW TO ENTER?

3.1. The promotion commences at 9am on Monday 1 February 2010 (AEDST) and entries close at 5pm on Friday 19th March 2010 (AEDST) ("Promotional Period").

3.2. To enter the competition, entrants must, during the Promotional Period, visit <http://westfield.com.au/aucentres/holiday>, input the required information and submit the fully completed online entry form. By submitting a fully completed online entry form entrants are agreeing to receive the Westfield e-newsletter and Wotif.com e-newsletter. If an entrant is already registered to either of these databases, they will continue to receive the Westfield or Wotif.com e-newsletter as normal.

3.3. Entrants will then receive a promotional email giving them the option to gain additional entries into the draw by referring friends. Individuals will receive an additional entry for each friend they successfully refer. To do so, entrants must forward the promotional email that they received to their friend's unique, valid email address. Each referred friend will then need to click on the link provided and follow the prompts to register to receive the Westfield and Wotif.com e-newsletters and enter the competition. The initial entrant will receive one (1) additional entry for each friend that they successfully refer (i.e. once their referred friend enters).
